Terms and Conditions. Please have all members of your party sign. I hereby sign that I have carefully read and understood the terms and conditions as they have been presented to me. I agree to follow all safety directions given to me by the tour manager. I will exercise reasonable care in all tour activities. I understand that Vitis Renaissance Tours reserves the right to withdraw me from the tour if my actions impede the safety, welfare or enjoyment of other tour members, at my own expense. I understand that Vitis Renaissance Tours purchases or reserves travel related services on my behalf from independent service providers and suppliers, that will serve and supply me throughout the tour, including transportation, accommodations, restaurants and wineries. As Vitis Renaissance Tours does not own or control any of these independent service providers and suppliers, it is not responsible for any delay, inconvenience, accident, expense, injury, loss, death, or damage occasioned through the conduct or default of any such service provider or supplier. Vitis Renaissance will do its utmost to provide the trip arrangements that have been confirmed, but I understand that they must retain the right to modify or cancel any trip, flight schedule, accommodation or arrangement, if unforeseen circumstances amounting to 'force majeure' arise.

Itinerary Cancellation. Vitis Renaissance Tours reserves the right to cancel an itinerary before departure for any reason whatsoever, including too few participants or logistical problems or any other circumstances that may make operation of the trip inadvisable. All trip payments received will be promptly refunded, and this refund will be the limit of Vitis Renaissance's liability without any further obligation on Vitis Renaissance's part. Vitis Renaissance is not responsible for any expenses incurred by me in preparing for the trip, including nonrefundable or penalty-carrying airline tickets, special clothing, visa or passport fees, or other trip-related expenses. Vitis Renaissance Tours strongly recommends trip cancellation insurance.

Cancellation Policy. Any cancellations must be made in writing to Vitis Renaissance. If cancelled:
61 – 90 days before your day of departure, a 75% refund of the cost of the tour, less the \$750 deposit.
31 – 60 days before your day of departure, a 50% refund of the cost of the tour, less the \$750 deposit
30 days or less: no refund will be issued.

Passports and Visa. I understand that I am solely responsible for ensuring that my passport is valid and will be for at least six months after the return date of my tour. Any delay or cancellations to my tour caused by passport issues are not the problem of Vitis Renaissance and may result in forfeiture of the cost of my tour. I am also responsible for any visa and health requirements needed to travel within the countries on my tour.

Health Insurance. Participation in the tour requires that I be in good health. I understand that all medical insurance and costs are my sole responsibility and that I am liable for any medical expenses incurred on the tour, including repatriation. Vitis Renaissance Tours strongly recommends taking out comprehensive medical insurance before you travel.

Assumption of All Risks. I voluntarily apply to participate in a tour under the arrangements of Vitis Renaissance Tours, with knowledge of the inherent risks and hazards involved in travel, including, but not limited to, motor vehicles, aircraft, trains, boats and all other conveyance; wineries and vineyards; traveling in remote areas; the forces of nature; civil disturbance; terrorism and government restrictions, which I agree to monitor; accident or illness in remote locations without access to rapid rescue or medical facilities, and the adequacy of medical attention once provided, including the medical personnel's ability to speak English. I have considered my own condition and limitations and concluded that I am physically and emotionally fit and able to participate in this tour. I am responsible for my own welfare.

Alcohol Policy. I understand that access to wine and other types of alcohol will be included on my tour. I am over 21 years of age by my date of departure. I am solely responsible for monitoring the quantity of alcohol that I consume and understand that Vitis Renaissance Tours will not be held responsible or liable for my consuming any alcohol, or any damage, illness or expense that may result from that consumption to myself or others. I understand that Vitis Renaissance Tours can and will ask me to leave the tour, at my expense, should my behavior hamper the enjoyment of or cause a hazard to other members of the tour.

Participation. Vitis Renaissance Tours reserves the right to decline to accept any individual as a tour member for any reason whatsoever.

Authorization to Use Photographs and/or Audio-Visual. Vitis Renaissance Tours may use, reproduce, and/or publish photographs and/or video that may pertain to me— including my image, likeness, and/or voice without compensation. I understand that this material may be used in brochures, e-mails, and online to promote Vitis Renaissance Tours and its product offerings.

Arbitration. Any controversy or claim arising out of or relating to this Agreement, whether or not specifically addressed in this agreement, shall be settled by binding arbitration in Seattle, WA, USA. in accordance with the rules of the American Arbitration Association. This agreement to arbitrate does not waive or modify the liability release contained in this document. The Superior Court of Washington for King county in Seattle shall have exclusive venue and jurisdiction over all parties in enforcing the terms and requirements of this release, including the enforcement of any arbitration award.

Waiver of Jury Trial. In connection with any action or legal proceeding arising out of this Agreement, the parties hereby specifically and knowingly waive any rights that either party might have to demand a jury trial.

Release. I acknowledge that I have had the opportunity to carefully read through these terms and conditions and have them reviewed by an attorney. In consideration of the services and arrangements provided by Vitis Renaissance Tours and subject to such acknowledgement, I, including but not limited to, my heirs, successors, assigns, beneficiaries, agents and legal representatives, do hereby release, hold harmless and indemnify Vitis Renaissance Tours, its owners, officers, directors, agents, employees, contractors, subcontractors and affiliates from any and all claims, liability, or losses for bodily injury, emotional injury or distress, property loss, damage or death which may arise from my participating in any Vitis Renaissance Tours. This release shall be legally interpreted to the fullest extent permissible and, should any part be held invalid, it is agreed that all other parts shall continue in full legal force and effect. I fully understand and agree to the contents and legal terms of this release. I understand that it is a legally binding contract and I am signing it of my own free will.
